Level IV Presentation

Yesterday students in grades 8-12 had the opportunity to hear <u>Dashka Slater</u> speak about her work as a storyteller, author, and journalist. Dashka is the author of several books for children and adults, including *The Antlered Ship, Escargot* and *The 57 Bus*. She is the recipient of a Creative Writing Fellowship from the National Endowment for the Arts and an award-winning journalist. Her articles have appeared in *Newsweek, Salon, The New York Times Magazine* and *Mother Jones*.

different audiences. She began the day speaking to our eighth grade students. In this talk Dashka focused on her work as a writer, relating her own career trajectory to her interests when she was in school. She shared her love of books and writing and described the interesting places that journalism has taken her including into the jaws of a lion and under the weight of a suit of medieval armor. Dashka also gave our eighth graders a window into the detailed work that is investigative journalism as she touched briefly on her latest book, *The 57 Bus*, a book that dives deep into an incident on a bus in Oakland, California that left one teenager severely burned and another facing life in adult prison after being charged with two hate crimes.



High School Presentation

Dashka's presentations to our high school students went deeper into the challenging themes presented in *The 57 Bus*. The crime that the book describes raises questions about race, gender, and fairness in our criminal justice system. At the start of her talk, Dashka asked our students about their concept of justice. She then took our students through the journey that she took in her reporting and helped paint a clearer picture of both the offender and the victim in the case. Dashka ended with a quote from Howard Zehr, the founder of Restorative Justice, "If crime is a wound, justice should be healing." She left our students wondering if justice was served in the case described by her book.

This discussion could not have taken place at a better time. The news over the past couple of weeks has many across the country discussing the behavior of teenagers, what their actions say about their values, and the implications that

teenagers about their feelings surrounding the allegations against Brett Kavanaugh. One teen, Maycee Wieczorek, a 17-year-old in Rapid City, S.D, phrased it perfectly when she said, "For me and my friends his past is our now." This is what I am hearing from our students. It is critically important that we provide our students with the time and space to think about and discuss difficult topics as they process how these issues apply to them. This happens regularly in our high school classrooms and we routinely seek out opportunities for our students to hear from other voices.

Yesterday while listening to Dashka Slater, our students thought hard about how a bad decision made by an adolescent changed two lives forever. They thought about the long-term implications of something that might have started as a joke. They thought about what justice is and how someone's race or gender might impact outcomes in our country's criminal justice system. The discussions continued in the hallways following her talk. These conversations will continue in classes as students reflect on literature and current events.

I'd like to thank Level II parent Jacqueline Veissid for putting us in touch with Dashka Slater and helping to bring her to SSCPS. Yesterday's talks were important for our oldest students as they pushed them to tackle challenging issues and helped open the door for continued discussion.
