A Message from Alicia

As we look toward the long weekend in honor of Dr. Martin Luther King Jr., it seems fitting that today's Weekly Update will address equal opportunity for all students and efforts the Commonwealth of Massachusetts is putting forth to alleviate some of the ongoing disparities that still plague the strongest public education system in the nation. One of the most difficult realities we as educators face is that disparity exists among the student populations we serve. Because we have over 25 sending districts, we are first hand witnesses to the ramifications of unequal opportunity that persist.

The funding formula provides a solid example of inequity. Students who come to us from less affluent towns most often have a lower per-capita tuition rate than the students who come from more affluent towns. As each sending city or town determines local educational funding to be added to the state funds, educational funding is not equal. For us here at SSCPS, the tuition number that follows a student from their sending district seems random. We do not provide one set of educational experiences for students coming from higher paying towns, and another set of educational experiences for students who come from lower paying towns. Yet statewide, unequal funding has been the status quo throughout Massachusetts for years.

Statewide lawmakers and educators have correctly realized that this formula creates disparity. That disparity is reflected in what educators and lawmakers call the achievement gap. This is the measured gap between different groups of students who are placed into categories the state refers to as subgroups. The subgroups that experience the most troubling achievement gaps are made up of students who have the greatest needs. Statewide these subgroups are *Students with Disabilities*,

Economically Disadvantaged, English Learners, and a combination of indicators, High Needs. Each of these subgroups require additional educational support to ensure that every student has access to curricula and educational programing so that each child can achieve their full potential. Educational opportunity for all children is a civil right.

Education is more than a funding formula. For over 25 years the state has struggled with the persistent achievement gap. If the objective of public education is to provide equal opportunity for all students, regardless of circumstance or zip code, policy makers have realized that effective remedies must be put in place. The Commonwealth has tried to mandate some remedies, however, in the past these have left schools and districts with unfunded mandates that fall to districts and towns to implement. Unfunded mandates quickly become another well-intentioned initiative where lack of funding takes its toll over time and inevitably falls short of the intended outcome.

Teachers in high needs districts are no strangers to educational initiatives that fizzle out. As professionals, they have learned to ride each wave to the end, holding the integrity of their practice firmly underfoot, ensuring that all students put before them are given the best education they can provide. However Herculean, efforts of individual teachers and district schools are not enough. Left underfunded, teaching and learning has persistently suffered; children fall through the cracks, teachers face defeat, schools suffer from poor accountability data, and the achievement gap persists throughout the state.

At long last, on November 20, 2019, the House and Senate approved the <u>Student Opportunity Act</u>; a bill that will increase public education spending by \$1.5 billion dollars over the next seven years. Governor Charlie Baker signed the act into law on November 26. The landmark education spending bill intends to provide the funding necessary for increasing student achievement for all students, but in particular, those students who fall into one or more subgroup. Although districts and charter schools have yet to see how those funds will be distributed, this is a strong step in the right direction.

Throughout Massachusetts, school districts will be asked to prepare plans on how funds provided by the act will be used to reduce and eliminate the achievement gap. The guidelines on these plans are scheduled to be released to districts over the next few weeks. In the meantime, the Commissioner has asked school leaders to communicate these preliminary stages to our school communities.

There are some ramifications of the Student Opportunity Act that we know now. Charter schools may also be eligible for additional funding. The Charter School Office at the Department of Education is working on revisions to the Annual Report Guidelines which will reflect the new requirements under the Educational Opportunity Act. As you may know, every year charter schools are required to submit an Annual Report to the state by August 1. We hope to be provided with the revised Annual Report Guidelines by late February or early March which will enable us to get working on our school wide plan as early as possible.

There are some steps we can take before receiving the official guidelines. One of the most important elements of the Student Opportunity Act plan is input from key stakeholders. Here at SSCPS, this includes all families. This year's Family Survey will include some demographic questions to assist us with our plan within the Annual Report. Please mark your calendar and set aside some time to participate in the

survey. The survey will be sent out to families with the Weekly Update on February 12, 2020. As always, if you have any questions about the survey, or need assistance translating the survey in your browser, please contact me directly.

Lastly, I would like to congratulate our sixth grade students and teachers for a terrific science fair yesterday. The exhibits were well researched and highly informative; the display boards beautifully done and carefully presented. We are so proud of all our sixth graders have accomplished, and impressed by our high school science mentors who supported their younger peers at all the right moments. Yesterday was truly a day of wonder and accomplishment, serving as yet another reminder of how fortunate we are to be SSCPS.



Basketball, Volleyball, Soccer, Baseball, Softball, Cross-Country and Track SSCPS student athletes are among the best in the league.


