School & Academic Report

State of the School Report: Alicia Savage, Executive Director reported

- SSCPS had a very terrific opening to the school year. It has been a busy two weeks. Thanked the Board for their support in leading the effort for expansion.
- Kindergarten students began the school year a day early they were able to see the building and adjust to school. In June 2017 we will welcome a new Kindergarten class and hold screenings. The 9th Grade students attended a day long trip to Project Adventure. It was a long day and thank you to the teachers who attended
- Reviewed the student assessment practice over the past five years from administering the MCAS to piloting the PARCC. FY16 test scores have been embargoed but will be released next month. SSCPS redirected from MCAS to prepare students for PSAT/SAT with the move to the PARCC. The state worked with College Board in developing PARCC. After analyzing two years of PARCC data it has become clear that some redesign of curricula is needed especially in math. Level II piloted Eureka Math and will begin implementation this year.
- Reviewed the SAT data over five years and compared to our largest sending districts. This data is being used during professional development and common planning time to improve student achievement. Recommend preparing students by providing students with test taking skills
- Reviewed the current enrollment number.
- Reviewed the Client Alert regarding the state ballot question
