Audit Presentation: Nicole Reilly, AAF

- FY23 Independent Financial Audit Presentation with a high level overview of the audit
- Audit was in accordance with DESE standard requirements as well as Federal audit standards.
- No compliance findings under the government and federal audits. Good news
- From a financial perspective from high level review there was increase in tuition revenues of \$1.2M from increase enrollment and funds from the Student Opportunity Act
- Expenses increase by about \$1.4M mostly due to the student transportation funding. State reimbursement is not expected to late FY24 for expense in FY23
- School did have a small loss of 372,000 offset by the Foundations activity for a net project for the school and foundation
- Other reports issued by the auditors: Management Letter which was clean and will go to DESE with Board
 report which outlines the standard communications. New activities with stagnant bank accounts with
 recommendation to look at receiving more timely cut off statements. Also, mentioned was an immaterial
 non-compliance in regard to W4 being received for employees during the year. Minor items reported
- There were no audit adjustments no materials findings or materials weaknesses to report
- The Finance Committee review the audit

Additional notes from Finance Committee: K. Poudrier reported

- Transportation reimbursement remains outstanding with a two-year lag in funding. Anticipate 80% reimbursement of cost from FY23 in June of 2024. The reimbursement schedule will be kept in mind during the work on the FY25 budget process
- In compliance with debt covenants on the mortgage loan. No vote needed

School & Academic Report

State of the School Report: Alicia Savage, Executive Director reported

- **Student Achievement:**
 - Congratulations to five seniors for their recognition by the College Board for outstanding academic achievement. In addition, one student received the National Hispanic Recognition Award
 - Congratulations to the 16 newest inductees the the SSCPS Chapter of the National Honor Society
 - SSCPS hosted Guess Speakers: Werner Salinger, Holocaust survivor presented to grades 7th and 8th grade, and two presentations at the high school. Caroline Kautsire from Malawi author of *What Kind of Girl*; presented at the high school

MCAS Scores from last spring: reviewed the scores for ELA, Math, Science.

- Before the scores were released, DESE met with Superintendents and Charter School Leaders and they
 report that the decline has stopped but the build back from COVID has not yet happened. It appears that
 our scores reflect that.
- Reviewed the MCAS data by grade and subject. Looked at the Next Generation MCAS annual comparisons. Reviewed the comparisons to the top sending districts. Looked at the growth data. Details are included in the: Executive Director Report October 19, 2023
- Reviewed the student PSAT and SAT results for grades 8-11
- New and continuing programs for 2023-2024: for Math iReady for grades K-8; for ELA Wonders has been introduced for K-4 with plans to include grade 5 in FY25. Keys to Beginning Literacy professional development was provided to all K-4 teachers throughout FY23. Collins Writing Program has been

reintroduced for grades 5-12 in Social Studies, History, and ELA. A literacy block for grades K-4 will be extended and professional learning have been established for teachers working with these grades. The DIBELS and Title I services will be extended to grade 5 for further monitoring.

Transportation Update:

- Family feedback received continues to be positive overall
- Additional routes and stops have been honed to better serve families
- Current ridership is approximately 788 students on 15 bus routes
- There are currently no families on the waitlist but some are waiting for openings on a more convenient route
- Student behavior has been acceptable for the most part, but areas of improvement remain
- Students on some routes have needed reminding about remaining seated and not switch seats when bus is moving
- Bus safety training will be provided by First Student on all grade levels in the coming weeks
- Bus driver shortage persists and we continue to work with First Student to minimize the impact

Enrollment:

- Current enrollment as of 10/13/23 is 1059
- Student withdrawal number from FY23 to FY24 as of October 1, 2023 is 86
- Four withdrawn students new to SSCPS
- Eleven students were "no shows" on the first day of school
- Reviewed reasons given: moving out of the district, academic, social/emotional, athletics, vocational educational, private school education, and transportation

DESE Charter School Convening - J. Juste reported

- J. Juste attended the DESE Charter School Convening meeting with A. Savage and K. Bingham
- Gathered some resources regarding indicators of distress for charter schools. There were also some activities with case studies which will be tabled until a further meeting
- J. Juste shared the <u>presentation</u> from the conference. Materials from the National Charter School Resource Center. More information is available at <u>www.charterschoolcenter.ed.gov</u>
- Focus is on the Governing Board and the five common themes of indicators of distress:
 - Lack of capacity to execute governance role
 - Out of touch with school population needs
 - No long-term sustainability strategy
 - o Inability to convene the board
 - o Boards' inability to hold school leaders accountable
- J. Juste asked Board members to participate in an activity to choose two indicators of distress for the board to focus on. Top indicators: governance role and holding school leaders accountable.
- This activity will be repeated in a few months to see if there are any changes
- There was some discussion regarding the indicators. There was also discussion regarding community engagement and ideas as to how to increase engagement through the Parents Association with the upcoming focus group scheduled for next week.

Committee Reports:

Faculty: K. Cianelli & K. Trowbridge reported

At 100:

- Across all levels, the Literacy Lane is coming up! Families have the opportunity to decorate the trunk of their car and trick-or-treat from car to car.
- Community outings with our special needs population is beginning tomorrow. They will be going to Boundless Bean Coffee and bakery shop and 5 below.
- Level I: Farm visits continue at Holly Hill this year. Students have the opportunity to get hands-on experience at the farm.
- Level II:Third grade has settled in nicely. They have worked a lot on expanding numbers to the hundreds and on regrouping with both adding and subtracting. In ELA, they're working a lot on finding textual evidence to answer questions, visualization as a reading strategy, and have focused a lot on subjects, predicates, synonyms, and antonyms. They'll be wrapping up the unit on culture and traditions soon, having enjoyed reading narrative nonfiction and realistic fiction. We're seeing more independence in our students as they become more used to the routines.
- Level III: This past month, Level 3 went on their annual Nantasket Beach team building trip. It was a beautiful day and students really enjoyed having time with their peers. Currently, the level is gearing up for their annual pumpkin carving contest. Each year students team up to carve a pumpkin with classmates. The pumpkins then get donated for the New England WildLife Center for their haunted trail of 1000 faces.

At the high school:

- The Cultural Diversity Workshop is conducting a Food/Clothing Drive to benefit the Charity Guild Organization in Brockton. Each advisory is encouraged to bring in canned goods and slightly used clothing. This event ends November 3rd.
- Today, Caroline Kautsire who is a published author came in to speak to the following classes: World Lit, AP African American Studies, the Cultural Diversity Workshop and the Author's Workshop. Students were given a copy of her book, *What Kind of Girl*.
- The National Honor Society had its induction ceremony this past Tuesday. We have 16 new members, bringing our chapter total to 38, which is the second largest group our school has had.
- The PSATs are tomorrow, and this is the first time they will be taking them digitally.
