- Conducted audit with a clean report for both the school and foundation with DESE and Federal audit standard were conducted

- Clean audit opinion was issued, no material weaknesses or significant deficiencies were identified
- FY24 was financial a good year \$1.5M increase and also increased the reserve from 4 month to close to 5 months
- Reimbursement for transportation was received in revenue and in the government grants. Plus increase in tuition rates. Able to maintain with exception of salary line due to grid increase

Executive Director School & Academic Report

State of the School Report: Alicia Savage, Executive Director reported

Executive Director Report

- There has been a lot happening at the school in the last 3 weeks. The Road Race was held and thanked everyone participated in a wonderful event
- The College Board has awarded the school with two distinctions. The AP Access Award recognizes SSCPS as providing all students the chance to participate in AP including students in underrepresented populations. The school also received the Gold AP 2024 Honor Roll. We received the gold recognition in college culture and college credit and platinum in recognition of the college optimization category. The last two enrollment increases allowed the school to expand the AP program and college awareness and acceptances.
- Holocaust Guest Speaker, Werner Salinger: On October 3 our school community was honored by the visit
 of guest speaker Werner Salinger who shared his Holocaust experience with our students in grades 8 and
 10. Mr. Salinger visited our school last year as a guest speaker and has come back to share his story with
 even more of our students.
- The SSCPS Annual Road Race was a splendid success. This year 150 runners and walkers made their way through Wompatuck State Park supporting our school with every step. As we celebrate 30 years, we remain honored by members of our Foundation, Board of Trustees, and alumni who were in attendance.
- MCAS results/reports were released on September 24. The results were reviewed with several graphs for ELA, Math, and Science for grades 3-8 and grade 10. Reviewed the sub-groups by students with disabilities, non-disabled students, high needs students, students in EL program, students by race/ethnicity. Refer to the Executive Director report for the detailed graphs.
- Enrollment: current enrollment is 1060. Student withdrawal number from Spring/Summer 2024 to October 7, 2024 is 125. Analysis of withdrawal data will be in the November Executive Director Report. Enrollment season begins November 1, 2024. Enrollment Open House is November 14, 2024.
